## **DECISION**

### **on foundation of the Economic Council of the Municipality of Žabljak**

#### Article 1

This Decision establishes the Economic Council of the Municipality of Zabljak (hereinafter: the Council), regulates the composition, method of election of members, manner of work and other issues relevant to its work..

#### Article 2

The Council is an advisory body of the Mayor for the area of economic and development policy of the municipality, which monitors and analyzes the situation in the economy, submits initiatives, proposes and undertakes activities in order to create conditions for improvement of the economy and development of relations of private-public dialogue.

#### Article 3

The tasks of the Council are to:

- propose activities and measures for creating a stimulating environment for attracting domestic and foreign investments and investments in projects in the municipality;
- propose to business entities measures for improvement of business environment with the aim to faster economic development of the municipality;
- identify needs for solving problems of the business community, in order to improve competitiveness and stimulate economic development;

- participate in the preparation, drafting and decision-making of importance for the development of the municipality's economy, strategic development documents and annual plans;- analyze and make suggestions on the budget draft;
- monitor and evaluate the degree of implementation of strategic plans, development projects and propose measures to the Mayor in this regard;
- propose forms of cooperation with the private, public and NGO sector to foster private-public partnerships;
- inform potential investors about the conditions and opportunities for investment and support programs at local and national level;
- promote the municipality at home and abroad as a favorable place for business and investment.

#### Article 4

The Council is consisted of the President and members.

The President and members of the Council are appointed by the Mayor.

Half of the total number of members of the Council is consisted of representatives of the largest companies and their associations, which bind their activity to the territory of the municipality of Zabljak.

#### Article 5

The President of the Council represents the Council, organizes the work of the Council, prepares and convenes the sessions, proposes the agenda, presides over the sessions, signs the documents adopted by the Council, cooperates with the competent authorities and public services and performs other tasks in order to exercise the function of the Council.

#### Article 6

The Council, as an expert and advisory body of the Mayor, carries out the tasks that are assigned to it by the decision on the appointment of the President and members of the council, passed by the Mayor.

#### Article 7

The council works on sessions.

The manner of work and decision-making and other issues relevant to the work of the Council will be further regulated by the Rules of Procedure, which the Council will adopt at its first session.

Article 8

Administrative and technical tasks for the needs of the work of the Council will be performed by an independent advisor for projects and local economic development in the Office of the Mayor.

Article 9

This decision shall enter into force on the day of its adoption and shall be published on the notice board of the Municipality.
